The Administration is to provide the following information:

#### Reply:

- (a) Since the actual expenditure on consultancies is a subject straddling various works departments, we will need time to collate the relevant information but should be able to provide a consolidated reply by 22 April 2005.
- (b) Works departments will engage consultants to help deliver projects at different stages if there are such needs due to lack of necessary expertise and/or in-house resources. Consultants, if needed, may be engaged in feasibility study, detailed design and/or supervision of works for both major projects under the LegCo Public Works Subcommittee/Finance Committee approval process as well as minor works under Block Allocations. When consultants are engaged, the consultancy fees will become part of the estimated cost of the projects for

expenditure under the Capital Works Reserve Fund. As consultancy fees only make up a small portion of the estimated cost of the projects and the expenditure is contingent upon the need, we do not have accurate estimates for the consultancy fees at the beginning of the financial year but expect they will generally follow the trend occurred in the past few years.
