3. Subject to the maximum point of the concerned RSS rank in the reference Government pay scale, incremental points shall be added to the minimum point of the concerned RSS rank to determine the reimbursement cap on salary of RSS subject to the following rules:
- (a) Other than the ranks of PRE, CRE and CRA, one incremental point shall be added for one complete year of satisfactory service as RSS at the concerned rank. Any omitted point in the pay scale of the concerned equivalent rank in the civil service will be handled similarly.
 - (b) For the ranks of PRE, CRE and CRA, one incremental point shall be granted at biennial interval upon satisfactory service as RSS at the concerned rank.
 - (c) For the ranks of RAIOW and RACOW, in addition to additional incremental points as specified in Sub-clause (a) above, a RSS who has served as RWSI or equivalent in any public works projects or those listed in Section 4.5.2 of this Handbook will accrue additional incremental points in accordance with the following table:

(d) For the rank of RPSII, in addition to additional incremental points as specified in Sub-clause (a) above, a RSS who has served as RACO, RACO(LR), RCA or equivalent in any public works projects or those listed in Section 4.5.2 of this Handbook will accrue additional incremental points in accordance with the following table:
