<p align="center">Sha Tin Sewage Treatment Works</p>	<p align="center">Relocation of sewage treatment works to caverns at Nui Po Shan, A Kung Kok, Sha Tin</p>	<p align="center">Under construction (Advanced works commenced in February 2019 and completed in April 2022. Construction of the main caverns commenced in July 2021 for substantial completion in 2026 to accommodate the sewage treatment facilities under the remaining works. The target is to commission the cavern sewage treatment works in 2029, and release the existing site of about 28 hectares in 2031.)</p>

Public Works Central Laboratory	Relocation of the laboratory to caverns at Anderson Road Quarry	Investigation and design commenced in December 2021 (Aim at completing the design by end 2022)
Archives Centre <i>(Note 2)</i>	Accommodation inside the caverns at Anderson Road Quarry	Investigation and design commenced in December 2021 (Aim at completing the design by end 2022)
Tai Sheung Tok Transfer Station <i>(Note 3)</i>	Studying the accommodation of a refuse transfer station inside the caverns at Tai Sheung Tok	Investigation commenced in May 2021 (Aim at completing the study in the first half of 2024)
