- Description** : The Development Bureau (“DEVB”) publishes this Invitation for Expression of Interest (“Invitation”) to invite prospective operators to submit the expression of interest (“EOI”) to become the Operators of the refreshment stalls at Central Harbourfront (near Central Pier Nos. 9 & 10) for the provision and operation of refreshment stalls. WestK Enterprise Limited (“WKEL”), a wholly owned subsidiary of the West Kowloon Cultural District Authority (“WKCDA”), serves as the Consultant of DEVB for managing the EOI process.
- Enquiry** : Enquiries can be made in writing to harbourfrontEOI@wkcd.a.hk no later than 2 working days before the closing date. Enquiries made thereafter may not be answered.

- Remarks** : (1) In case Tropical Cyclone Warning Signal No. 8 or above is hoisted, or Black Rainstorm Warning Signal or “extreme conditions” announced by the Government is/are in force for any duration between 9:00a.m. and 6:00p.m. (Hong Kong Time) on the EOI submission closing date, the closing date and time for EOI submissions to the email address specified above will be extended to 6:00p.m. (Hong Kong Time) on the first working day (i.e. Monday to Friday except public holidays) after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning

Signal or the “extreme conditions” announced by the Government has/have ceased to be in force.

- (2) All costs and expenses incurred for, or in connection with, any response to this Invitation, including the preparation and/or submission of EOI, shall be entirely the responsibility of the interested parties.
- (3) The Government of the Hong Kong Special Administrative Region and/or WKEL do not bind themselves to accept or respond to any EOI submissions and reserves the right to suspend, not to proceed with, or to cancel this Invitation or to negotiate with any prospective operator.
- (4) Open EOI is adopted. All interested parties are invited to submit their interest to this Invitation. The qualifications / conditions of participation are stipulated in the EOI Documents.
