Note 1 註 1

- (a) "Romunerated directorship" include all directorships for which a fee, honorarium, allowance or other material benefit is payable.

- (b) Only remunerated directorships of local companies are registrable. 只須登記在本地公司的受薪董事身分。
- (c) Remunerated directorships through corporate directors are also registrable.
