

Admission to the List of Approved Contractors for Public Works in the Hong Kong Special Administrative Region (HKSAR)

How can Contractors Participate in Hong Kong's Public Works Projects?



Admission to the List of Approved Contractors for Public Works ("Approved List")

- The Development Bureau (DEVB) of the HKSAR Government maintains the Approved List to ensure selection of reliable and capable contractors in an efficient manner that meets the fast pace of the public work programme of Hong Kong.
- Normally, contractors on the Approved List are invited to submit bids for public works contracts.
- Contractors not on the Approved List can still bid our public works contracts by forming a joint venture with contractor(s) already on the Approved List.

Admission Criteria – Full compliance with WTO GPA – No barriers for overseas contractors

Six Core Criteria



Points to note:

- Application for admission to the Approved List is at all times open to applicants from local or overseas, with the same set of non-discriminatory admission rules.
- Applicant's local or non-local experiences will be considered.
- On admission, a contractor –
 - must possess or set up a place of business in Hong Kong;
 - is normally given a probationary status which limits the number and value of public works contracts it can undertake. Upon satisfactory execution of public works contracts of certain value, the contractor can apply for a confirmatory status.

Experience Requirements

- ◆ Contract(s) executed outside the HKSAR shall be over HK\$2,000 million.
- ◆ The standard of relevant construction works shall be on par with that of public works in the HKSAR.
- ◆ Information on contract(s) executed outside the HKSAR shall be authenticated by the relevant government authority, consulate, etc. of the country where the contract was carried out.

Application Procedures
