#### **Construction Site Safety Manual**

#### **Purpose**

This memo is to revise the Construction Site Safety Manual (the Manual) to reflect the enhancement to the Safety Management System (SMS) for public works contracts with a view to sustaining the effort on site safety as well as to simplify and streamline the existing administrative work.

#### **Background**

- 2. The SMS for public works contracts was first developed in 1993. The SMS was reviewed from time to time with implementation of enhancement measures (including the introduction of the Pay for Safety Scheme (PFSS) and also the Pay for Safety and Environment Scheme (PFSES)) to meet the contemporary requirements in delivering public works contracts.
- 3. In mid-2015, we conducted a review of the SMS, including PFSS and PFSES, for public works contracts with the objectives to sustain our effort on site safety as well as to simplify and streamline the existing initiatives and the corresponding administrative work. One of the review areas is on the appropriateness of the items in the Bills for the PFSS/PFSES.
- 4. After the review, we propose to make the following enhancements, among others, without compromising site safety. The proposal was endorsed by the Works Policies Coordination Committee at its meeting held in September 2016.
  - (a) The PFSES would be renamed as the PFSS.
  - (b) All environmental related pre-priced payment items from the Bills for the PFSES would be removed and then combined in an appropriate item to the Bills for Preliminaries. The pre-priced items in the PFSS should only contain the following:
    - (1) site specific induction training;
    - (2) toolbox talks;
    - (3) participate in promotional campaign;

- (4) pre-work activities of Site Safety Cycle;
- (5) safety training for specified trade workers;
- (6) provide safety officer;
- (7) safety meeting;
- (8) safety walk; and
- (9) prevention of heat stroke (new item).
- (c) To minimize administrative efforts, the method of measurement for some of the items (including those moved to the Bills for Preliminaries) will be simplified site specific induction training, toolbox talks and pre-work activities of Site Safety Cycle will be regarded as lump sum items.
- 5. Further, to consolidate safety requirements, we take this opportunity to incorporate the requirements under the Environmental, Transport and Works Bureau Technical Circular (Works) No. 30/2002 to the appropriate sections of the Manual with amendments for streamlining administrative work.

#### **Policy**

- 6. All public works contracts, including design and build contracts and term contracts, the tender of which are issued **on or after 20 April 2018** shall implement the enhancements through incorporation of the provisions at the revised Chapters 3 and 12 of the Manual.
- 7. The updated Manual can be downloaded from the website of the Development Bureau. The revision history of the Manual is attached in **Appendix A**. In addition, a list of relevant pages in the Manual that need to be updated is attached in **Appendix B** for easy reference.
- 8. The Environmental, Transport and Works Bureau Technical Circular (Works) No. 30/2002 is hereby superseded.
