**Ranks of authorised officers and requirements  
for approval of variation orders (“VOs”)**

Prior to the issuance of VOs, the works departments and their consultants need to ensure the availability of funds and compliance with the following approval requirements:

**Table 1: Ranks of authorised officers for approval of VOs based on estimated value of individual VO in accordance with Stores and Procurement Regulations**

<b>Rank of authorised officer for approval of VOs</b>	<b>Estimated value of individual VO</b>
Public officers at Engineer level or equivalent	Up to \$200,000
Public officers at Senior Engineer level or equivalent	Up to \$400,000
Public officers at D1 level or above	Up to \$1.3 million
Public officers at D2 level or above	Up to \$4 million
Controlling Officers (generally heads of works departments)	No limit

**Table 2: Ranks of authorised officers for approving of VOs based on estimated final contract sum after including all VOs in accordance with Stores and Procurement Regulations**

**Table 3: Requirements for authorising project consultants to issue VOs under departmental guidelines and provisions of consultancy agreements**

Project consultant	<p>Up to \$300,000 (provided that the estimated final contract sum after including all VOs, would not exceed the total sum of the original contract value and the contingencies specified in the contract.)</p> <p>The requirements in Tables 1 and 2 are applicable to other situations.</p>
