Salvation Benevolent Association

We refer to your letter to our client and us dated 15 June 2011.

We are instructed to return herewith the completed form (the "Form") to you.

By way of background, on 3 November 2010 and 18 March 2011, you asked our client to return the same form and indicate its views on the same Town Planning and Land/Lease Information. Our client replied, by way of our letters to you dated 17 November 2010 and 22 March 2011, with objections and protest.

Our client, once again, disagrees with the information set out in Columns 5 and 6 of your current letter, as it does not consider it is in breach of the relevant planning or zoning requirements. Our client does not agree it has breached the relevant lease conditions either. Further, the user restrictions provisions in the relevant land lease are still under consideration and investigation by the District Lands Office/Kowloon West. Pending the investigation result, it is inappropriate for you to request for such a declaration from our client. In any event, our client, yet again, objects to your proposal to include Salvation Benevolent Association in Part B of the Information on Private Columbaria in the first place.
