Any person intends to deposit human remains in the premises ought to check and confirm with the operator about the arrangement for the removal of human remains if in case such termination notice is served.
- 5. This surveyed structure is only being tolerated temporarily. The squatter control survey number can be cancelled and the surveyed structure be cleared at any time by the Government.
