文物保育的重要性

香港在過去一個半世紀，由一條細小的漁村，蛻變成為亞洲國際都會。歷史文物見證着本港的發展，亦是我們獨一無二的寶貴資產。

平衡文物保育及發展

發展與保育並非對立的，我們會在持續發展和保育文物兩者之間取得平衡。我們會推行一套措施，

加強文物保育工作。本小冊子介紹「活化歷史建築伙伴計劃」的內容。

活化再利用政府歷史建築

我們希望將這些建築物好好地活化再利用，為它們注入新生命，供市民大眾一同享用。

計劃

目標

- 保存歷史建築，並以創新的方法，予以善用。
- 把歷史建築改建成為獨一無二的文化地標。
- 推動市民積極參與保育歷史建築。
- 創造就業機會，特別是在地區層面方面。

運作模式

- 物色適宜作活化再利用的政府歷史建築，以納入該計劃。
- 申請機構須就如何以社會企業形式使用上述建築物，以提供服務或營運業務遞交建議書，詳細說明如何保存有關的歷史建築，並有效發揮其歷史價值；就財務可行性而言，社會企業可如何營運；以及如何令社區受惠。
- 成立由政府和非政府專家組成的評審委員會，審議建議書及相關事宜。

- 我們會向成功申請的機構提供一站式諮詢服務，以推行其建議計劃，服務範疇涵蓋文物保護、土地用途和規劃、樓宇建築，以及遵從《建築物條例》的規定。
- 在有理據支持下，我們會在該計劃之下提供資助，包括：
 - 一次過撥款，以應付建築物大型翻新工程的部分或全部費用；
 - 就建築物收取象徵式租金；以及
 - 一次過撥款，以應付社會企業的開辦成本和最多在首兩年營運所出現的赤字（如有），但先決條件是，建議的社會企業預計可在開業初期後自負盈虧。

申請資格

《稅務條例》(第 112 章) 第 88 條所界定的非牟利機構，均可申請。申請機構須提供證據，證明曾推展與建議書所載規模相若的項目。此外，亦歡迎非牟利機構合營。

IMPORTANCE OF HERITAGE CONSERVATION

Over the past one and a half centuries, Hong Kong has transformed from a small fishing village to Asia’s world city. Heritage bears witness to the development of our city and is a valuable and unique asset of our community.

BALANCING CONSERVATION AND DEVELOPMENT

Development and conservation are not opposing forces. We will strike a balance between sustainable development and heritage

conservation. We will implement a package of measures to enhance heritage conservation. This leaflet describes

the “Revitalising Historic Buildings Through Partnership” Scheme.

ADAPTIVE RE-USE OF GOVERNMENT-OWNED HISTORIC BUILDINGS

Through good adaptive re-use of our historic buildings, we aim to give these buildings a new lease of life for the enjoyment of the public.

THE SCHEME

Objectives

- To preserve and put historic buildings into good and innovative use.
- To transform historic buildings into unique cultural landmarks.
- To promote active public participation in the conservation of historic buildings.
- To create job opportunities in particular at the district level.

Mode of Operation

- Government-owned historic buildings considered suitable for adaptive re-use would be identified for inclusion in the Scheme.

- Applicants can submit proposals for using these buildings to provide services or business in the form of social enterprise.

In their submissions, they should come up with detailed plans to show how the historic buildings would be preserved and their historical significance be brought out effectively, how the social enterprise would operate in terms of financial viability and how the local community would benefit.

- A vetting committee, comprising Government and non-Government experts, will be set up to consider the proposals and related matters.
- We will provide one-stop advisory service for successful applicants to take forward their proposals in the areas of heritage conservation, land use and planning, building architecture, and compliance with Buildings Ordinance.
- Where justified, we will provide financial support including:
 - one-off grant to cover the cost for major renovation to the buildings, in part or in full;
 - nominal rental for the buildings; and
 - one-off grant to meet the starting costs and operating deficits (if any) of the social enterprises for a maximum of the first two years of operation on the prerequisite that the social enterprise proposal is projected to become self-sustainable after this initial period.

Eligibility

Non-profit making organisations with charitable status under Section 88 of the Inland Revenue Ordinance (Cap 112) will be eligible to apply. Applicant organisations have to provide evidence of their track record in delivering projects commensurate with their proposals. Joint ventures of non-profit making organisations are welcome.
